The clinic is run by volunteer dentists who dedicate their time in, not only providing quality dental care, but also shaping young dentists and dental students.
- In addition to dental treatment, the Ben Massell Dental Clinic also provides wrap around care for its patients. The social services department aids in reconnecting patients with the much-needed medical care, financial aid, housing resources, vision services, and dental referrals.
- The clinic also provides mental health and domestic violence counselling to patients.

- Will work with the social services manager and data manager to review a report of the most common chronic and infectious diseases in the patient group.
- Will develop presentations to address the above-mentioned reporting and solve for barriers.
- Will deliver health presentations in the waiting room and provide health education pamphlets.
- Will educate patients about the connection between dental health and systemic health and work to improve health trends in patients.
- Will document every patient interaction for further review
- Will guarantee compliance with patient privacy standards, National Association of Social Workers' Code of Ethics, HIPAA guidelines.
